

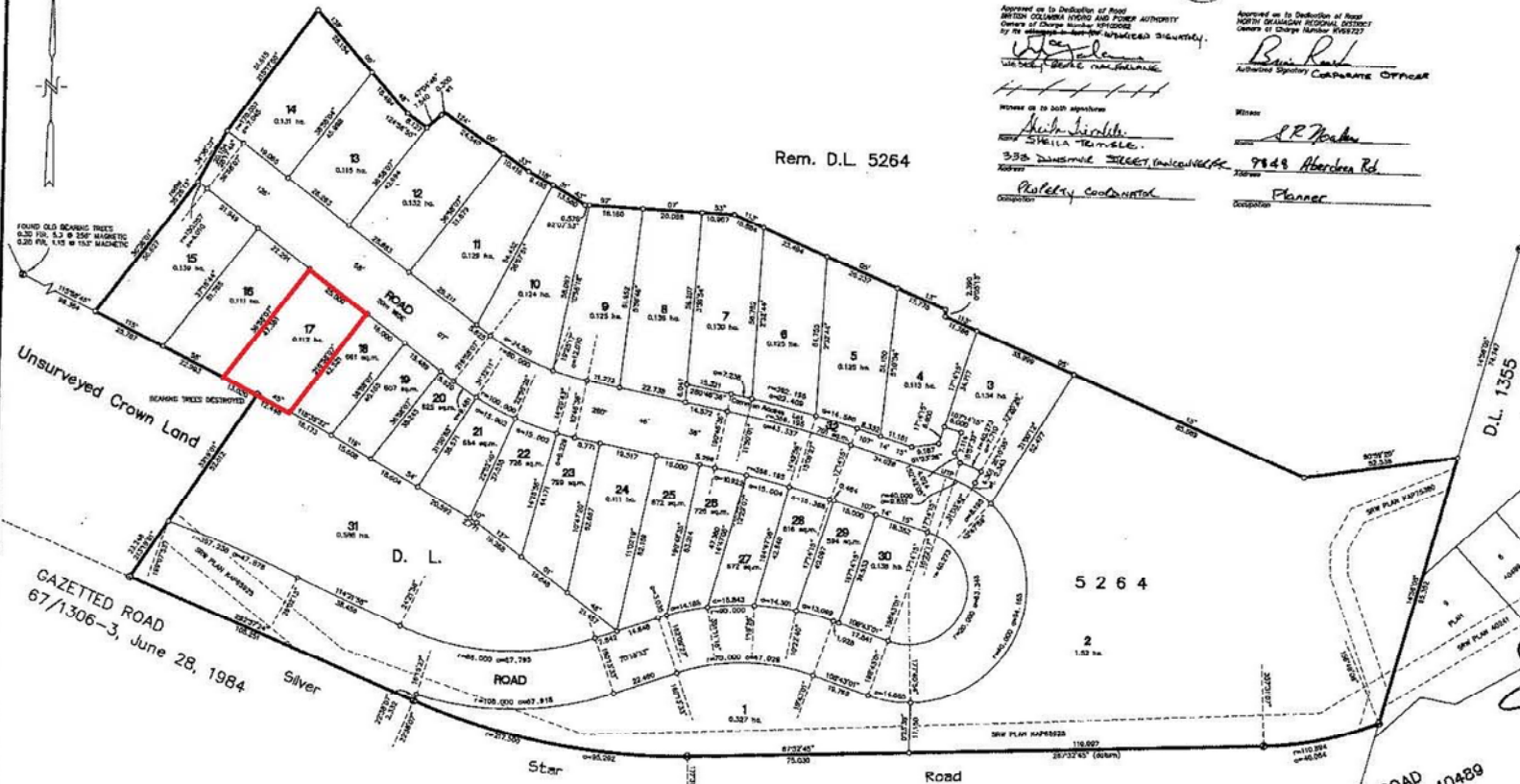
PLAN OF SUBDIVISION OF PART OF D.L. 5264, O.D.Y.D.
